NOTICE INVITING TENDER

Sealed tenders are invited from reputed LED lighting systems manufacturers/ suppliers for manufacturing, supply, fitting & fixing of 150 nos. of 20W rated LED based luminaires fixture (LED based Light) sets to be used as street lights for retrofitting to operate on 230 V A.C., 50 Hz supply. These systems in bulk are to be installed anywhere in the State of West Bengal. These systems are to be of outdoor application type. The tender has to be submitted in two parts as described below.

Part-A: Eligibility:

The documents related to minimum eligibility conditions as given below should be submitted in a separate envelope super scribing "Documents related to eligibility conditions"

- a) The supplier/manufacturer should have full-fledged manufacturing/ servicing unit in West Bengal. The manufacturer should have servicing facility of his own.
- b) The supplier/manufacturer should have credential for supply of such products in any Government organization.
- c) The LED & Fittings both have to have test certificate from any Government accredited test centre.
- d) Earnest money of Rs. 10,000 (Rupees ten Thousand) only would be deposited , shall have to be enclosed along with the tender in the form of demand draft/ bankers cheque which would be drawn in favour of "Director, WBREDA" payable at Kolkata. A/C payee cheque will not be entertained. The EMD value would be adjusted according to @ 2% of the offered value. NSIC/SSI units having permanent registration will get exemption from EMD subject to producing valid certificate.
- e) The manufacturer should submit current copy of valid trade license, PAN Card, VAT and Service Tax Registration Certificate, I.T returns documents, audited balance sheet for 2011-12, 2012-13 and 2013-14 (no undertaking will be entertained) would have to be submitted. P.F. & ESI Registration would have to be submitted, if any.
- f) Total turnover shall be to minimum 20 lacs in the last three financial years.
- g) Offer is to be submitted in WBREDA's original tender sheet. Improperly filled up tender sheet or typed copy of the tender sheet will be treated as canceled.

Part-B: Techno- financial offer:

To be submitted in separate envelope super-scribing "Techno financial offer" for LED based luminaries fixture (LED based light) set to be used as street light for retrofiting.

The application would be received to this end on any working days from 27/06/2014 to 07/07/2014 between 11:00 AM to 03:00 PM.

Tender document can be obtained from WBREDA Office, Kolkata (Bikalpa Shakti Bhawan) on submission of application between 11.00 a.m. to 3.00 p.m. on any working day on & from 27/06/2014 to 07/07/2014.

Tender documents duly filled in and signed along with official seal, must be put in the proper envelope duly sealed with clear recording of the tender notice number and due date on the envelope and should be submitted to this office on or before 07/07/2014 up to 2-30PM and the tenders will be opened at 3.00 PM on the same day in presence of intending bidders, if any.

Tenderer should quote their rate in fixed and firm inclusive of all taxes and duties, VAT, Service Tax etc. as applicable in West Bengal in this respect. The validity period of tender must be atleast 01(one) year from the date submission of tender document.

WBREDA does not bind itself to accept the lowest tender and reserves the right to split order on more than one contractor/manufacturer/supplier. WBREDA may reject any or all offers without assigning any reason whatsoever.
