Name of Work:

DGPS Survey for area demarcation for 30 acre land allocated for setting up of ground based solar power plant project of capacity 7 MWp at the premises of DPL including contour survey, geo referencing and fixation of boundary pillars.

Scope of Work:

A. Topographical survey of area for ascertaining the nature of land topography. Survey to be conducted for the land actually available for the purpose of development of site layout with following details:-

1. To survey land boundary with co-ordinates of each corner points and dimension of each arm by total station including internal angles of corners. Distance between two adjacent points should not exceed 45 meters.
2. Fly leveling to fix up one reference point at suitable location and securing the reference point with appropriate arrangement so that it can be used as Temporary Bench-mark for the project.

- B. 1. Measurement of total area of land,
2. Development of AutoCAD drawing with supply of hard copy and soft copy
3. Geo referencing
4. Fixation of boundary pillars
5. HFL data of the area from India Meteorological Department or any other recognized source

C. Details of any internal road, pond, tree, hillock or valley etc, if any, within the land to be surveyed
