1.0 Introduction :

West Bengal Renewable Energy Development Agency herein referred to as **WBREDA** invites e-tender (Submission of Bid through **online**) through Domestic Competitive Bidding (DCB) from eligible bidders for following work:-

Title of the Work:

“Repairing work for restoration 14 numbers of defective GRTSPV Systems including five years comprehensive maintenance of 55 numbers GRTSPV Systems each of array capacity 10 kWp at different locations in West Bengal”

2.0 Number of systems and capacity of GRTSPV system:

55nos. GRTSPV systems each of array capacity 10 kWp.

3.0 Brief Scope of work

- a) Comprehensive Maintenance after repairing and making operational of the defective fourteen (14) numbers GRTSPV System each of capacity 10 kWp.
- b) Comprehensive Maintenance of 41 numbers of numbers of existing operational GRTSPV System each of capacity 10 kWp
- c) The comprehensive maintenance shall include Routine Maintenance, Preventive Maintenance and submission of maintenance report of all 55 numbers of GRTSPV Systems (Detail Scope is elaborated in Terms & Condition under Section V)

If the offer is submitted without or inadequate Earnest Money (Bid Security), the bid may be opened. Incomplete offer may be liable for rejection.

9.0 Qualifying Requirement For Bidders:

9.1 General

The bidder should be a company registered in the state of West Bengal under the Indian Companies Act, 1956 /Partnership Firm / Limited Liability Partnership having legal entities and having the clearance of all statutory obligations. The Bidder must be registered in the state of West Bengal

9.2 Technical Capability

The Bidder, as primary agency, must have credential of satisfactory execution of contracts for setting up of PV Power Plant of each of minimum capacity **5 kWp** and/or Solar Pump each of minimum capacity **1kWp** of total minimum cumulative capacity **165 kWp** anywhere in India within past 7 (seven) years ending last day of month previous to the one in which NIEt are invited.

9.3 Financial Capability

9.3.1 The bidder should have a Minimum Average Annual Turnover (MAAT) **@ 30%** of the Estimated Project Cost during last 03 (three) consecutive financial year **ending on 31st March 2020**

9.3.2 Net Worth¹ for the financial year ending on **31st March 2020** should be positive.

¹“Net worth” means the aggregate value of the paid-up share capital and all reserves created out of the profits and securities premium account, after deducting the aggregate value of the accumulated losses, deferred expenditure and miscellaneous expenditure not written off, as per the audited balance sheet, but does not include reserves created out of revaluation of assets, write-back of depreciation and amalgamation.

- 10.0 Validity of offer:** Validity of the offer is 180 days from the date of opening of the techno-commercial bid. However, it may be extended in case of exigencies with consent from the successful bidder(s).
- 11.0** WBREDA is not bound to accept the lowest tender. WBREDA reserves the right to accept or reject any bid partly or fully or cancel the bidding without assigning any reason thereof and in such case no bidder/ intending bidder shall have any claim arising out of such action.
- 12.0** WBREDA reserves the right to split the work among more than one bidders.
- 13.0** If the dates of any offline activity and opening of Technical Bid and Financial Bid fall on holidays or on days of strike or natural calamity, the dates get deferred to next working days at same hours without any further notice.
- 14.0** A prospective bidder requiring any clarification on bidding documents may notify the WBREDA by uploading the same in the e-tendering portal, which shall be available to all the participant bidders, as per Standard Format enclosed with this document **Form 3 and Form4** not later than the date and time specified in NIT.
