9.0 The successful bidder has to be submitted Additional Performance Security @ 10% of the tendered value, if the bid value stands 80% or less of the estimated cost put to the tender. And will be released after successful completion of commissioning.

Qualifying Requirement for Bidders:

The Bidder must have to meet the following conditions for participation of bidding:

General:

The Bidder, who intends to participate in the Bid, must have to meet the following:

- The Bidder shall be a Registered Company/Firm/Proprietorship/Registered Co-operative society incorporated in India under the Companies Act, 1956 or 2013/Indian Partnership Act, 1932/LLP Act, 2008/ societies registration including any amendment thereto.
- Bidder must meet the eligibility criteria independently as Bidding Entity Financial Capacity:

The Bidder, who intends to participate in the Bid, must have to meet the following criteria:

1. Minimum Average Annual Turnover (MAAT) of the Bidder shall at least **Rs. 4.5 Lakh** (30% of the Estimated Cost) during any 03 (three) financial year out of last seven (07) consecutive year ending on 31st March 2025.
 - MAAT will be calculated from the audited annual accounts; certified, signed by the chartered accountant with relevant UDIN number.
2. Liquid Asset ** of the Bidder shall be at least **Rs. 1.50 Lakh** Bidder shall have liquid assets or/and evidence of access to or availability of credit facilities to make good the shortfall in liquid asset, if any.
 - [Liquid Asset and Net Worth will be judged from the balance sheet, duly certified by Charter Accountant and it is to be uploaded by the potential bidder. **Such documents should not be three months older.**]
3. Net Worth for last five (5) years should be positive.
 - The Bank Solvency will be judged from the relevant documents, issued by appropriate Bank Authority and it is to be uploaded by the potential bidder. **Such documents should not be six months older. From the date of publication of this tender.**
4. If 70 % or more LD is imposed on any bidder in any govt. job within the last five years, that bidder will not be considered as eligible bidder in participation in the tender. A declaration in non- judicial stamp paper is to be submitted along with the bid document by the bidder. Affidavit-X

Technical Capability

The prospective bidders shall have satisfactorily completed **as a prime agency** (not as a member of joint venture or sub-contractor) during the last 5(five) years prior to the date of issue of this NIEt at least **one work** of similar nature having a magnitude of 40(Forty) percent of the Estimated amount put to tender of intended job.

or, the prospective bidders shall have satisfactorily completed **as a prime agency** (not as a member of joint venture or sub-contractor) during the last 5(five) years prior to the date of issue of this NIEt at least **two works** of similar nature having a magnitude each of minimum value of 30(Thirty) percent of the Estimated amount put to tender of intended job.

or, the prospective bidders should produce credential **as a prime agency** (not as a member of joint venture or sub-contractor) for at least one single running work of similar nature having work value of 80% or more [of the estimated amount put to tender of intended job.

OR

Turnkey workers as listed in MNRE website or Bidders having Credential for participation in National Bio Gas Mission Program or equivalent.

**Liquid assets are cash or financial resources that can be rapidly & securely converted into cash within a few days, without a significant loss value.

11. Completion time:

Completion period for the project are as follows:

13.0 WBREDA is not bound to accept the lowest tender. WBREDA reserves the right to accept or reject any bid partly or fully or cancel the bidding without assigning any reason thereof and in such case no bidder/ intending bidder shall have any claim arising out of such action.

14.0 If the offer is submitted without or inadequate Earnest Money (Bid Security), the bid will not be opened. Incomplete offer will be liable for rejection. Exemption of EMD will be given for Registered Labour Co-operative Societies, MSMEs in West Bengal within the ambit of relevant provisions, as laid down by the Government of West Bengal.
